

Job Description Board of Directors Member

The board of directors is the controlling body of the organization. The board is responsible for all major decisions regarding mission, policy, finance and operations.

Duties of Members of the Board of Directors

- Attend scheduled board meetings, arriving fully prepared
- Be knowledgeable of, and able to represent Planned Pethood in regard to, the organization's mission, finances, organizational structure and operations
- Maintain board confidentiality
- Abide by the Planned Pethood Volunteer Agreement
- Participate on a minimum of one committee, or hold an officer position
- Attend a minimum of one adoption event and one fundraiser per election year
- Expect to spend a minimum of five hours of participation per month on board matters

Minimum Qualifications

- Ability to interact with other board members and volunteers, and function as a team
- Ability to communicate and receive documents via email
